- It is expected that all vendors will be ready and able to sell at the time of event opening and may not leave any earlier than the end of the show.
- Vendors will behave in good conduct, keeping their area free of debris.
- Holiday Pop Up Market is not responsible for any loss, damage or theft of property, injury to or death of the Vendor (or it's employees and/or personnel). The Vendor assumes all risks of loss, damage to or destruction of any its property resulting from any cause.
- Vendors must have a temporary or permanent CA seller's permit by the time you vend with us. California law states that you must have a seller's permit in order to make sales. You are considered a retailer if you are selling any tangible items to customers.
- Vendors agree to adhere to all laws, policies, rules, and regulations applicable to the goods offered by the Vendor, including obtaining all licenses, permits, and approvals that may be required to enable the Vendor to fulfill all its obligations in this agreement.
